◆ **Meeting Agenda:**

1. **Delivery of complaint links to the heads of student representative Boards.**
2. **Standardization of logos.**
3. **General statement on the mechanism of the student representative Boards work.**

◆ **Topics that discussed during the Meeting:**

1. The President of the Student Representative Board indicated that he has been contacted by several student representative Boards from various colleges regarding their facing some difficulties and challenges in dealing with their college administrations. He pointed out the necessity of handling the current situation of each Board wisely and avoiding, as much as possible, an aggressive or confrontational approach.
2. The President of the Student Representative Board indicated that the administrative body has generally prepared the strategy, and there are some simple procedures that remain for its approval, which they are currently working on, such as presenting it to several officials and so on.
3. The President of the Student Representative Board indicated that several contents and activities have been prepared by the Communication Committee, which will be published on all social media platforms of the Student Representative Board. Additionally, the Boards accounts will be utilized to support other student councils and clubs that need assistance.
4. The President of the Student Representative Board indicated that four events have been prepared for the Student Representative Board by the Events Committee, which will be announced as soon as approval and endorsement are obtained from the officials.
5. The President of the Student Representative Board indicated that a meeting was held with the logo designers from the Branding and Creative Services Department, specifically with Ms. Al-Anoud Al-Kuwari, to design an approved and unified logo for all student representative Boards; this correspondence lasted for nearly two months.
6. The president of the student representative Board referred to the general statement of the operational mechanism of the student representative Board for the colleges, which grants it full freedom and authority in its management. The role of the administrative body of the student representative Board is merely oversight and supervision; if matters get out of control, or if any issues concerning the Board are raised to the administrative body, or in the case of communication with external parties, the administrative body will then intervene.

7. The president of the student representative Board indicated that the monthly reports would serve as oversight and supervision only, and intervention will only occur in the cases mentioned above. They will merely serve as a basis for the presidents in front of the officials in case the officials request a report on the work of each Board.
8. The president of the student representative council suggested some advice to increase the effectiveness of the student representative Boards for the colleges, including conducting tours of lectures within the college to familiarize students with the role and importance of the student representative Board.

◆ **Meeting Report:**

1. Links for complaints specific to each student representative Board will be sent separately by the secretary of the student representative Board; each president of the student representative Boards who wishes to do so must send their email address.
2. The logos for the student representative Boards have been approved, and as a result, all councils must adhere to placing this logo on their official documents and so on.
3. A report for the month of September will be sent to all presidents of the student representative Boards, to be written and submitted at the beginning of October.
